Official rules for LBA Queen of Hearts Progressive Raffle

1. The Lafayette Band Association (LBA) is a non-profit 501(c)(3) organization, and holds a current Kentucky charitable gaming license #0841. The LBA is approved to hold weekly Queen of Hearts raffles to take place during Thursday night Bingo sessions.
2. The LBA has purchased a Queen of Hearts board from a certified gaming vendor. The board displays a deck of 54 playing cards (including two jokers) sealed face down and numbered one (1) through fifty-four (54). No one knows where the Queen of Hearts card is on this pre-sealed board.
3. Tickets are \$2 each, and may only be purchased during LBA Bingo gaming sessions on Thursdays at Lex Go Bingo, 1230 Eastland Dr, Lexington, KY. Tickets may only be purchased in-person with cash, and are available beginning at 6 PM, with sales concluding at the end of BREAK 2 (see Bingo Program for a detailed schedule). Tickets will only be sold to persons 18 years old or older, and prospective purchasers may be asked to verify their age by presenting a current government-issued ID indicating the prospective purchaser's date of birth.
4. There is no limit on the number of tickets that can be purchased each Thursday. Tickets are only valid for the QoH drawing on the night the tickets were purchased. Tickets may not be carried over or held back for any future drawing.
5. Numbered ticket stubs must be placed into the drawing cylinder by the purchaser prior to the end of BREAK 2. The LBA is not responsible for tickets whose stubs are not placed into the drawing cylinder by the purchaser.
6. Matching numbered ticket halves MUST be held by purchasers. Drawing winners MUST be present and must provide their matching ticket half to win the night's drawing. Purchasers are strongly encouraged to put their name and address on the back of each ticket half. If a winning ticket half has a name and address on the back, it must match the name and address of the presenting person as verified using a current government-issued ID.
7. Only one person may own each ticket, and only that one person will be considered the raffle winner for the purposes of selecting a card to be revealed AND for the purposes of prize payouts. Any tickets with more than one name and/or address written on it is invalid and will be discarded if drawn. Ownership of any ticket without any name or address written on it is determined by physical possession of the matching ticket half. Any damaged or torn ticket held in part by more than one person is invalid and will be discarded if drawn. The LBA does not recognize group purchases and any such arrangements are entirely the responsibility of the individual ticket purchaser.
8. Lost tickets cannot and will not be replaced under any circumstances.
9. The jackpot for each night will be the larger of (i) the total revenue from the night's ticket sales plus any carry-over jackpot from the previous Thursday (see details of carryovers, below), or (ii) \$2000.
10. Drawings will be conducted between games 11 & 12 each Thursday Bingo night.
11. Drawing winners, after presenting a matching ticket half, are required to provide, in writing on a "winner's slip", their name, address, and phone number, as well as the number of the card to be revealed.
12. All drawing winners, after completing the winner's slip, will receive a voucher for a free \$30 computer, and the numbered card indicated on the winner's slip will be revealed. The drawing winner will win an additional prize if certain cards are revealed:
 - a. Any Jack - \$25
 - b. Any King - \$50
 - c. Any Ace - \$75

- d. Any Queen other than the QoH - \$150
 - e. Any Joker - The drawing winner will receive 20% of the current jackpot with the LBA receiving a further 10%.
 - f. The Queen of Hearts (QoH) - The drawing winner will receive $\frac{2}{3}$ of the current jackpot with the LBA receiving the remaining $\frac{1}{3}$.
13. Carry-over jackpot amounts and new QoH boards:
- a. If the QoH is revealed, the entire jackpot will be paid out as described above, and there will be no carryover jackpot. A new QoH board will be used for the next week's drawing.
 - b. If a Joker is revealed, 30% of the jackpot will be paid out as described above, and the remaining 70% will carryover to be included in the next week's jackpot. The current QoH board will continue to be used for the next week's drawing.
 - c. If any other card is revealed, no portion of the jackpot is paid out, and the entire jackpot will carryover to be included in the next week's jackpot. The same QoH board (with one less unrevealed card) will be used for the next week's drawing.
14. After the night's drawing winner is confirmed and selected card revealed:
- a. The winning ticket, stub, and winner's slip will be stapled to the revealed card, and the revealed card reattached, face up, to the QoH board.
 - b. All remaining ticket stubs will be removed from the drum and destroyed per DCG regulations. Tickets do not carry over from drawing to drawing. New tickets must be purchased for each week's drawing.
15. Once the Queen of Hearts or a Joker is revealed, the board will no longer be in play and will be placed in storage and kept according to guidelines of the Kentucky DCG.
16. All full or partial jackpot winners must be at least 18 years old, and are responsible for any and all applicable state, local and/or federal taxes. The winner will be required to complete a Form W2G (1099) before receiving any prize payout. Once the W2G has been completed and a copy made of the winner's current government issued ID card, up to \$2000 will be paid to the winner in cash. Any remaining prize due will be paid via certified check sent via US Mail no later than the Tuesday following the drawing. If the total prize due is \$5000 or more, the LBA will withhold required tax prepayments, both Federal and State, from the monies paid via check.
17. If a full or partial jackpot winner does not or cannot complete a form W2G (1099) and/or satisfactorily provide a current government issued ID to be copied, no prize will be paid out. The winner will have 15 days to complete required paperwork. If, after 15 days, no W2G and/or ID has been provided the full prize will revert to the LBA.
18. A full or partial jackpot winner cannot donate the prize without first taking ownership of the prize, which means the appropriate W2G must be issued and the appropriate withholding taken. If a winner then wants to donate the prize, he/she can do so.
19. The LBA reserves the right to amend these rules as needed prior to any week's drawing. Any change to these rules will be announced in the Bingo Hall prior to any drawing.
20. This contest is void where prohibited by law.
